2016 Fire Inspections

All state mandated fire inspections and fire code enforcement in all new and existing buildings, except for 1 & 2 family dwellings in the district were completed for 2016. We continued doing inspections with the new software available from the State of Wisconsin and new mobile equipment.

This new software made available to the fire departments throughout the State of Wisconsin from Image Trend for 2016 worked flawlessly. We could inspect and then track our re-inspections as needed without any problems. The new HP computer we purchased for the inspection software used off line also worked flawlessly.

In 2016 we did a total of 1129 annual fire inspections in the district. There were 642 inspections in Weston, 284 in Rib Mountain, 32 in Stettin and 2 in Town of Marathon. Included in that number is 2 occupancies in Rib Mountain that must be inspected twice yearly and 29 in Weston. There were 75 occupancies that needed a second or more re-inspections.

2016 also was a busy year for new business and or change of occupancy's which requires an inspection before they opened or reopened for business. There were 56 of these inspections done for business in Weston, 18 in Rib Mountain and 1 in Stettin.

I also attended a Fire Inspection Principles class at the National Fire Academy, it was a two-week intensive class on fire inspections which I learned a lot from and could interact with inspectors from all over the country. Once again, I attended the 2016 Wisconsin State Fire Inspectors Convention in Lake Delton, Wisconsin. It featured presentations by inspectors from all over the country and many vendors who answered questions on codes and other inspection related services available to inspectors in Wisconsin. It was very informative and a great way to talk with other inspectors from the state to share ideas and to see how other inspectors handle everyday inspection related topics.

Commonly Observed Fire Code Violations:

Fire extinguishers inspected annually Automatic fire protection systems (sprinkler and fire alarm systems) inspected annually. Fire door and laundry and trash chute inspected annually Hood suppression systems inspected annually (must be serviced every 6-months) Elevators Inspected Annually Inoperative exit signs and emergency lighting Blocked or locked fire exits (fixed immediately) Poor housekeeping and storage practices (dryers not clean, garbage not removed)



Fire Response by Station Station 1 83 37.55% Station 2 138 62.45%





2016 was a successful year at SAFER regarding safety and employee health. Within the calendar year SAFER conducted 13 employee safety related trainings, 3 safety committee meetings, and over 12 public safety outreach to local schools, businesses, and originations. There were 24 safety incidents reported throughout the calendar year. 3 of the incidents resulted in worker's compensation reporting; resulting in a total of \$9,281.75 of charges to the district and additional dollars in shift coverage wages to cover these injuries. During the month of October ten total fire safety presentations to area schools reaching over 4,000 children under age 14.

During the summer of 2016, Safety Officer Nitzke attended the Wisconsin Safety Council Conference and brought back safety related trainings and ideas to help improve the overall health and safety to the employees of the SAFER District.

In the fall of 2016 SAFER continued to provide flu influenza vaccinations to employees who wished to participate. And began an outreach to the families of members and the local community. The employee vaccinations filing process was also revamped and organized to better ensure the health of our employees and those who we serve, including students who also participate in ride-along internship opportunities with the district.

South Area Fire District is proud of its safety commitment to its employees, members of the community, and visitors to our communities. All safety violations or incidents are thoroughly investigated with utmost focus on prevention of future incidents and continuous training.




